

The police urge you to pay attention to the following:

- You must be in possession of a valid ticket in order to gain access to the stadium, and you must have a valid ID, which must be presented on request.
- It is a criminal offense to buy and sell drugs.
- It is not allowed to possess fireworks, flares or the like in the stadium. People who light, or possess, fireworks will not be allowed to enter the match.
- Anyone in possession of knives or weapons will be arrested. The fine is approx. 600 Euro and / or imprisonment.
- It is a criminal offense to throw bottles or the like
- It is a criminal offense to make racist statements.
- It is a criminal offense to be threatening or violent.
- It is a criminal offense to sell tickets on the black market.
- It is not allowed to stay in the stadium in a section to which you do not have a ticket.
- Supporters with quarantine will not be allowed access to the stadium.
- Anyone in possession of clothing or effects with associations with ultra or hooligan groupings will be denied access to Parken.
- Police directions must be followed at all times.

- It is advisable to arrive at the stadium well in advance of the match. Due to security reasons, all guests will be searched before being given access to the stadium. This may cause delays when larger groups of fans arrive at the stadium.
- Only spectators with a valid ticket will have access to the stadium.
- It is not recommended that visitors purchase tickets on the black market. These tickets may be stolen or fake and thus invalid. Guests in possession of stolen or fake tickets will be arrested and prosecuted.
- For safety reasons, it is not possible to move between the different sections of the stadium.
- After the match, the visiting spectators must expect to wait for up until an hour before they can leave the stadium


